Extended coverage warranties that are purchased through Alpine Payment Systems (APS) will cover all hardware and software issues on the equipment leased as a part of your contract with APS, including but not limited to: severe damage to displays, keypads, magnetic read heads, excessive debris buildup resulting from failure to perform recommended cleaning, operation of equipment outside of the normal duty cycle, electrical and environmental conditions, spillage, and any other damage caused by abuse, misuse, negligence or acts of god. This warranty does **NOT** cover separate equipment from prior purchases or leases with other companies, but only the units leased as part of your agreement with APS.

Compliance Assistance Program:

The equipment leased will be compliant with current PCI / VEPP security standards. Alpine Payment Systems will provide continued compliance assistance for a period of thirty-six (36) months. This compliance assistance program is considered null and void if service with Alpine Payment Systems and/or its processing affiliates is terminated.

Termination of Extended Warranties:

Extended coverage warranties shall only last for as long as processing and leasing agreements stay in force between Alpine Payment Systems and Merchant. If these agreements are terminated, extended warranties and compliance assistance program end on the date of termination.

Choice of Law & Forum:

These warranties shall be enforced as interpreted by the law of the state of Washington (without applying its conflict of laws principles). Parties agree that any disputes shall be resolved via mandatory and binding arbitration, using the Commercial Arbitration Rules of the American Arbitration Association, and an authorized Arbitrator from the American Arbitration Association. The arbitration shall be held at the closest possible location to Clark County, Washington. The arbitration award shall be enforceable in any court having jurisdiction over the parties. Merchant agrees to bear all the liability for costs associated (including attorney's fees) with arbitration and resolving the dispute.

Miscellaneous:

This agreement is intended to be binding and valid legal instrument. If any part of it is deemed unenforceable, necessary provisions shall be modified to the extent to make it enforceable, but in no way shall it invalidate any other portions of this agreement. No delay by Alpine Payment Systems in enforcing any rights shall be deemed as a waiver of said rights.
